

## Michigan 4-H Shooting Sports Instructor Certification and Recertification Policies and Application

Effective May, 2018

### **Certification Policy**

To receive initial MI 4-H Shooting Sports Instructor Certification Applicants must:

- 1. Be an enrolled 4-H Volunteer that has been approved through the Volunteer Selection Process or be an approved teen leader.
- 2. Attend and participate fully in a MI 4-H Shooting Sports Board of Directors approved instructor certification workshop
- 3. Pass the test for your discipline
- 4. Complete the four (4) on-line volunteer e-learning course modules prior to the workshop.
- 5. Meet any other discipline specific qualification/certification requirements and approval of the state trainer responsible for your discipline. Trainers have the right to deny certification to anyone they feel is not prepared to safely lead a 4-H Shooting Sports Program/Club/Event.
- 6. Deliver the MI 4-H Shooting Sports Instructor Certification/Re-Certification Application to your county 4-H office where county staff will verify the activity status of the instructor, sign and date the application and update county records as needed. Trainers will have signed this form for all successful applicants at the workshop.
- 7. County 4-H staff will submit the **original** completed MI 4-H Shooting Sports Instructor Certification/Re-Certification Application with all required signatures within 90 days following the workshop to <a href="mailto:chris483@anr.msu.edu">chris483@anr.msu.edu</a> or the following address:

8. Your instructor certification card will be emailed from the state office to the county office. County staff should copy cards and distribute them to the applicants in a timely manner.

#### Please note:

- Original, completed forms can be mailed/emailed to the state shooting sports coordinator
   (<a href="mailto:chris483@anr.msu.edu">chris483@anr.msu.edu</a>) by the county staff. County staff and applicant should both keep copies of forms for their records. The forms MUST be emailed or postmarked within 90 days of the workshop. For example, for the April 28-29, 2017 workshop, the application must be emailed or postmarked by July 29, 2017.
- It is ultimately the responsibility of the applicant to insure that forms are completed properly and mailed on time.

### **Re-Certification Policy**

To **renew** MI 4-H Shooting Sports Instructor Certification:

Using the original certification date of April, 2017 as an example...

The recertification process is:

- 1. Certifications expire on December 31<sup>st</sup> of each year. The renewal application process should begin October 15th of the year certification expires (2020), or three years from the year of certification or most recent recertification. The completed, dated, and signed application should be received by the county 4-H office where county staff will verify the activity status of the instructor, sign off on the application and update county records as needed. A signature from a current certified shooting sports instructor supporting certification is required for renewals only. Be sure your form reaches your County 4-H Program Coordinator in a timely manner for completion of their portion of the forms.
- 2. Applications should be sent to the state office prior to certification expiring so certification does not lapse. Applications received after December 31<sup>st</sup> are considered lapsed and require a workshop to renew.

County staff and instructors should both keep copies of applications for their records. It is ultimately the responsibility of the instructor to insure that applications are completed properly and mailed on time.

- 3. If the application is filled out correctly and the instructor has remained active, the instructor certification will be renewed, the application will be filed, the database will be updated, and a new certification will be emailed to the county 4-H office. The staff person should then ensure that the new card is given to the instructor.
- 4. This recertification process should be repeated in three years... (in this example, fall of 2023).
- 5. If the instructor attends a state certification workshop prior to the established recertification expiration (2020), for example, if they attend a certification workshop in the same or different discipline in October of 2017, their new recertification expiration date becomes 2020 provided the instructor meets all requirements listed above. Recertification would then be due in 2023.

#### Please note:

- Instructors seeking re-certification who have been <u>inactive</u> for more than three years, or whose
  certifications expiration date has passed without being renewed **must** attend a state 4-H
  Instructor certification workshop for one of their past certifications before all of their disciplines
  will be renewed. Successful completion of a certification workshop will renew **ALL** certifications
  that have lapsed.
