Section 1 – REQUIRED:

Cost:

- ✓ **Nutrition Facts Label - Pre/Post Label Review** \$121.00/hour
Applies to each project that requires **NEW** recipes to be submitted for Nutrition Facts labels calculation based on one hour review.

Additional work requested that exceeds typical amount of time spent will be charged \$121.00/hour.

Section 2 – Check ONE of the following:

- **Nutrition Facts Label (Single)** – one column of nutrient values \$100.00
Multiple Analyses (per additional requested at the same time and/or within 6 months of the Nutrition Facts label approval) \$ 75.00
- **Nutrition Facts Label (Dual)** – two columns of nutritional values \$150.00
Multiple Analyses (per additional requested at the same time and/or within 6 months of the Nutrition Facts label approval) \$125.00
- **Nutrition Facts Label (Aggregate)** – multiple columns of nutrient values \$200.00
- **Nutrition Facts Label for a Specialty Ingredient** \$ 50.00
Existing nutrient analysis from a specialty ingredient is formatted into a label.

If the final Nutrition Facts label results in the same nutrition for individual flavors of products (e.g. only a seasoning change) the fee will be for one Nutrition Facts label. However, an additional cost, based on hourly rate, will be charged to create the recipe for the other product flavors. (Individual Ingredient Statement fee will apply.)

Section 3 – Check ALL that apply:

- **Nutrition Facts Label – Package/Serving Size Change (single)** \$ 30.00 each
Serving size change or additional package size requested (excluding original size requested) and is based on an existing recipe already calculated for Nutrition Facts.
- **Nutrition Facts Label - Recipe Adjustment (up to 3 ingredients)** \$ 40.00 each
Includes the addition, subtraction and substitution of ingredients or modifying the amounts of current ingredients (any number of ingredient weights) on an existing recipe calculated for a Nutrition Facts label.

Recipe adjustment fee will be honored if request is made in conjunction with original request and/or within 6 months of nutrition facts label approval.

- **Nutrition Facts Label - Recipe Adjustment (3+ ingredients)** \$ 75.00 each
Includes the addition, subtraction and substitution of ingredients on an existing recipe calculated for a Nutrition Facts Label.

Recipe adjustment fee will be honored if request is made in conjunction with original request and/or within 6 months of nutrition facts label approval.

- **Additional Nutrition Facts Label** 50% of label fee
Different format from selection in Section 2
- **Nutrient Analysis Report** \$100.00
Multiple Analyses (per additional requested at the same time and/or within 6 months of Nutritional Facts label approval) \$ 75.00
- **Nutrient Analysis Report + Nutrition Facts Label** \$150.00
Analyses (per additional requested at the same time and/or within 6 months of Nutritional Facts label approval) \$125.00
- **Specialty Ingredient (single)** \$ 25.00 each
Recipes that require the addition of specialty ingredient nutrient analysis for completing the Nutrient Facts calculation. This information will be provided by the customer. Fee covers the time to input data on specialty ingredients.
- **Sub-Recipe (single)** \$ 25.00 each
Recipes that require the addition of a sub-recipe, to be input separately and incorporated into the main recipe for the Nutrition Facts Label.
- **Addition of Expanded Fat Profile** \$ 30.00
Adding of the polyunsaturated and monounsaturated fatty acids as calculated, placed under the trans-fat nutrient value.
- **Addition of “Lab” Nutrient Values** \$121.00/hour
Replacing the calculated nutrient values in the Nutrition Facts Label with lab amounts per FDA serving. Nutrient values will be adjusted according to FDA rounding guidelines. Determination of this adjustment is product specific and reviewed if appropriate. (*Fee is based on time to complete the task.*)
- **Voluntary Nutrients - added to Nutrition Facts Label** \$ 30.00
Request for additional nutrients to be added to the standard 14 nutrients per FDA requirements.
- **Ingredient Statement** \$ 25.00
Simple modifications to provided statement per client preference.

- **2016 Nutrition Facts format (new projects only)** \$121.00/hour
This fee, based on hours, is in addition to the fee defined in Section 1.
- **2016 Nutrition Facts format (previous Nutrition Facts projects)** \$ 60.50/hour

- **FDA regulations for serving size, format and label review** \$121.00/hour
- **Nutrition Facts Nutrient Content & Health Claim Review** \$121.00/hour
Evaluate Nutrition Facts values and compare to FDA standards
- **Previous Nutrition Facts Projects – Pre/Post Label Review** \$121.00/hour
Review of updated Nutrition Facts due to changes in recipes, package size or serving size (per FDA regulations)

One Nutrition Facts - 100% due **before** work is started.

Multiple Nutrition Facts – 50% of the Cost Estimate due to start work. Remainder due upon completion of work, **prior to receiving final copies.**

NOTE: Balance due upon receipt of final invoice -----1.5% applied on every 30 day range, starting with 2nd month notice from initial invoice billing date.

Additional Notes:

Description of Services:

- Nutrition Facts Label
 - Nutrition Facts data
 - Serving size (2016 FDA label compliance to Industry Guidance document)
 - Servings per container
 - Ingredient statement (preliminary, based on recipe)
 - Allergen statement (based on recipe ingredients only and not product ingredients)
- Nutrient Analysis
 - Nutrition profile of over 160 nutritional components.
 - Can be generated per serving or per 100 g.
- Specialty Ingredients
 - Data Processing Fee
 - Charge for each specialty ingredient that is not in the database.
 - Note: The database contains over 72,000 food items – including brand name items, fast foods, baby foods, food ingredients, and common items.
- Nutrition Facts Label - Pre/Post Label Analysis Review
 - Review the completeness of the recipe input form for nutrient analysis accuracy and compliance to FDA – Code of Federal Regulations (21CFR: 101.9 & 101.12)
- Correspondence/Additional Services (charged against hourly fee)
 - E-mails
 - Phone calls
 - Nutrient content claims
