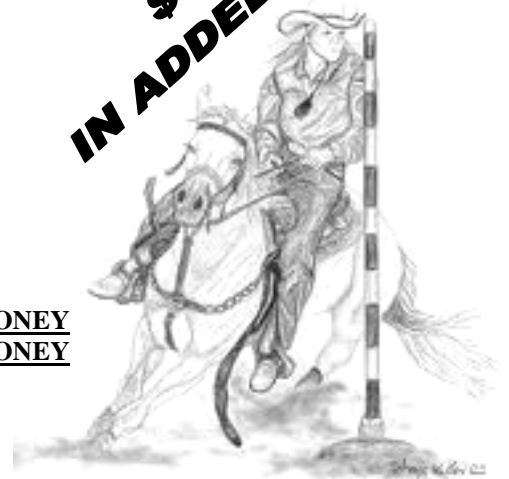
Open & Alumni Classes are \$10.00 per class (Must have 10 riders in the class for the added money.) 70% payback.
