

# Ada May and Webb Harwood Memorial Scholarship Application



**Due November 11<sup>th</sup>, 2024 to the Washtenaw County MSU Extension Office**

## **Scholarship Guidelines:**

1. Applicant must be an incoming freshman, or higher continuing their education at an accredited institution of high education. (Four-year institution, two-year, community college or trade/vocational schools all qualify).
2. Available to any current or former Washtenaw County 4-H member, Washtenaw County Youth, or Washtenaw County FFA member who is outstanding in Home Economics project areas and has shown at least 2 years at the Washtenaw County 4-H Youth Show or the Saline Community Fair. Home Economics project areas include food and nutrition, food preparation, food preservation, personal appearance: clothing, knitting, crocheting, and buymanship.
3. Available to any current or former Washtenaw County 4-H member, Washtenaw County Youth, or Washtenaw County FFA member who is actively involved in animal science projects or is pursuing an education in animal science, agriculture field of study and have shown for at least 2 years at the Washtenaw County 4-H Youth Show or the Saline Community Fair.
4. These two fields of studies will take precedence over others first, however, other areas of study will be considered and are asked to apply.  
Judging will be based on participation, involvement, leadership, and citizenship.
5. Scholarship award preference may be extended to those currently involved in home economics/human ecology or animal science; however, other areas of study will be considered.
6. Incoming freshman, as well as college sophomores, juniors, and seniors are eligible. Max amount of dollars not to exceed \$4,000.00 by one individual. You may continue to apply, winning up to that dollar amount. No scholarships will be given for a period longer than four years.
7. At presentation, the recipients' presence is expected but no required. Recipients must provide a copy of a tuition receipt to receive scholarship funds. Scholarship recipients must refund any money not used for educational purpose or at an institution or higher education or trade school.
8. One letter of reference needs to accompany each application. It may come from school, leader, friend, employer. It must be with the scholarship application.
